Vote By Mail

August 29 | First day to apply for vote by mail

September 29 | First day ballots will be sent out

Voting by mail is a great way to ensure you never miss another election due to an unexpected emergency. You can cast your vote by returning the ballot via mail, leaving it in a county drop box, or bringing it to your polling place on Election Day.
